HOW TO OBJECT TO THE REGISTRATION OF A LASTING POWER OF ATTORNEY (LPA)

Objection to the registration of an LPA may be made to the Office of the Public Guardian OR to the Family Justice Courts.

A. Making an objection to the Public Guardian

(1) An objection to the registration of the LPA may be made to the Public Guardian on the following grounds:

- the donor or donee is a bankrupt (for powers that relate to the donor's property and affairs)
- the donee is a licensed trust corporation whose licence has lapsed or been revoked, or who has been liquidated, wound up or dissolved, or is under judicial management (for powers that relate to the donor's property and affairs)
- the donor or donee has passed on
- there has been a dissolution or annulment of the marriage between the donor and the donee (unless the LPA has provided that such an event does not terminate the appointment of the donee or revoke the power)
- the donee lacks the mental capacity to be donee
- the donee has disclaimed the appointment

(2) If you wish to make an objection to the Public Guardian, you must complete OPG Form OBJ 1 and submit it to the Public Guardian together with documentary evidence of the facts supporting your reasons for the objection by the Specified Date (mentioned in paragraph 4 on page 1 of this notice).

(3) The Public Guardian will proceed to process the LPA application if no objection is received by the Specified Date.

(4) You may download OPG Form OBJ 1 from the OPG website: www.publicguardian.gov.sg.

B. Making an objection to the Family Justice Courts

(1) An objection to the registration of the LPA may be made to the Family Justice Courts on any of the following grounds:

- one or more of the requirements to apply for an LPA has/have not been met, e.g. the donor lacks mental capacity to make the LPA
- the power created by the LPA no longer exists, e.g. the donor has revoked it while he/she has mental capacity to do so
- there has been fraud or undue pressure used to induce the donor to make the LPA
- the donee has behaved, is behaving or proposes to behave in a way that would contravene his/her authority or would not be in the best interests of the donor.

(2) If you wish to make an objection to the Family Justice Courts, you must file an application to the Family Justice Courts and give a copy of the court application to the Public Guardian by the Specified Date. You should consult a lawyer if you are unsure how to proceed with the court application.

(3) The Public Guardian will proceed to process the LPA application if a copy of the court application is not received by the Specified Date.
